AGE ELIGIBILITY

Eddie Herr is a USTA International Tournament which is subject to ITF Regulations . The age-eligibility rules for this event follow Year of Birth (unlike USTA junior rules which follow month of eligibility).

ITF Age Eligibility Guidelines for 18s: The 2021 ITF World Tennis Tour Juniors is open to players born between the 1st January 2003 and 31st December 2008. Players are eligible to compete on the ITF World Tennis Tour Juniors in the year they turn 13 years of age, if they have reached their 13th birthday on or before the start of the Singles Main Draw of the tournament they are competing in, until the end of the year in which the player turns 18 years of age.

U12s will play 2 Tie-Break sets and a Match Tie-Break (10 point) in lieu of a third set with regular scoring. U14s and U16s will play full 2 out of 3 Tie-Break sets.

U18s will follow the ITF Rules and Regulations.

- One match per day will be scheduled for singles.
- If you sign up for doubles during the main draw week, you may have two matches that day.
- If weather becomes a factor, the Supervisor/Referee has the authority to change the schedule.
- Night play may become necessary on one of IMG Academy's lighted courts.
- Scoring may be changed due to weather conditions at the discretion of the Supervisor/Referee and Organization.
- No spectator coaching during matches will be permitted.


