# ORGANIZER CHECKLIST

The "Organizer Checklist" can help guide you through the registration process. For your convenience, we organized the items in the checklist chronologically by due date.

DU	E THREE WEEKS PRIOR TO ARRIVAL:
	<b>Schedules</b> – A schedule is due three weeks prior to arrival. Our staff will work to compile a schedule that fits the needs of each group as best as possible. Changes to schedules after they have been confirmed will be reviewed and are subject to availability.
	<b>Sport Specific Equipment List</b> – We will assist by providing our sport specific equipment for usage during your training sessions. Please submit your list of preferred equipment as soon as possible, but no later than three weeks prior to your arrival. Once we receive your list, we will confirm what is available. If equipment is damaged or not returned, there will be a replacement cost charged to your account.
	<b>Athletic Trainers/ Physios</b> – We require that an athletic trainer/physio be present during any training on our campus, depending on group size and activity, in order to use our facilities. In the event groups/teams cannot provide their own athletic trainer/physio we can assist with securing one for them. However, please note that athletic trainer/physio requests should be submitted at least three weeks prior to arrival. <i>Any last minute requests may be at an additional expense and will be subject to availability.</i>
	<b>Certificate of Liability Insurance</b> – Any groups/teams that have been instructed to provide a Certificate of Liability Insurance (COI), should provide it three weeks prior to arrival. Please note that groups/teams that do not submit a COI (if required) will not be permitted to use our facilities on campus.
	<b>Credit Card on File</b> – We require a working credit card belonging to the party responsible for payment be kept on file for incidentals and any room damages that may occur during your visit. We will place a hold of \$250 or 2% of the total reservation (whichever is greater) on the card at the time of booking that will be fully refunded post visit, provided there are no outstanding incidentals and/or room damages.
DU	E TWO WEEKS PRIOR TO ARRIVAL:
	Rooming List – If staying on-campus, a rooming list should be submitted a minimum of two weeks prior to your arrival. Any last-minute changes to the rooming list will be subject to availability and may be an additional expense and/or may delay the check-in process. Information needed as part of the rooming list includes:  Name  Date of Birth  Role (Coach, Player, Staff, etc.)  Dates of Check-In/Check-Out.
	<b>Waiver &amp; Indemnification/Agreement to Participate Forms</b> –Each attendee must submit a signed <i>Waiver &amp; Indemnification</i> and <i>Agreement to Participate</i> to participate or use our facilities. Any attendee under the age of 18 must submit a <i>Waiver &amp; Indemnification</i> and <i>Agreement to Participate</i> signed by a legal parent/guardian. Hard copies of completed forms can be sent via mail. <i>However, please bring the originals to check-in</i> .
DU	E 72 HOURS PRIOR TO ARRIVAL:
	<b>Guest List</b> – IMG Academy is a closed campus and only pre-authorized visitors will be allowed on campus. As such a guest list should be provided to us at least 72 hours prior to your arrival or their access to campus may be delayed.

- The athlete's identification card (issued at check-in) acts as a meal card and must be presented in order to enter the Student Dining Hall and to be served.
- If your group will require dinner meal delivery outside the times above, we will provide a hot meal to-go from 7:30-8:30 PM. Any requests between 8:30-10:00 PM will receive a cold boxed meal.
- If you require a full meal delivery outside the meal times and parameters set above, all requests will be handled on an individual basis depending upon circumstances involved and there will be additional costs associated.
- Your group will be provided the menu that is planned for your visit. If any changes are requested, we will review with our Food & Beverage Department to determine if there will be an additional charge. Please note that on Sundays there will be a continental breakfast served.
- Our lunch and dinner menu comes with two proteins, pasta, vegetable, starch, salad bar and fruit. We also serve a full hot breakfast with the exception of Sundays which is continental and includes muffins, fruit, English muffins, bread, yogurt, fruit salad, oatmeal, and juices.

#### **Laundry and Linens**

- Wash/Dry Service If you would like for us to launder your items, the cost is \$2.00 per pound.
- A washer and dryer are provided in all of the units at Champions Walk and Academy Park Villas.
- Additional cleanings and towel services can be provided at an additional cost.

#### Meeting Space

- Depending on the room type you are scheduled to use, there are audio and video capabilities available. Most meeting rooms at IMG Academy are equipped with VGA and HDMI connections. It will be up to the group to bring their own laptop to hook up to the video projector. Please ensure if you are using an Apple computer, you bring the proper converter.
- Most of IMG Academy meeting rooms have wifi or hardlines.

#### **Athletic Trainers/Physios**

• While you are practicing or in competition an athletic trainer/physio is required. If you do not have a trainer/physio in your group and need to secure one, the cost is \$32 per hour. The trainer can be available 1 hour before practice for taping and 30 minutes after practice for icing and treatment. The trainer will also have all supplies.

### **Gym/Weight Room Access**

• If your group has purchased access to the gym/weight room facilities you will be required to stick to your designated time. We cannot guarantee access to the facility outside of the approved scheduled hours.

#### **Room Damages**

• It is up to the guest to go through and check to make sure there are no damages in the room upon check-in. If the guest services desk is not notified within the first 2 hours of check-in, the assumption is that the damage was done after arrival. IMG Academy will assess the damages and come up with the value repair costs. The guest will be notified of the total charges. The credit card on file will not be charged until the guest confirms the method of payment.

#### **Weather Safety**

• In case of rain or other inclement weather, sport programs or access to facilities may be shortened or altered. Weather safety will be announced via a horn on campus. Please seek shelter and wait for confirmation we are off weather safety. If you are a college or professional group you may sign documentation to allow you access to facilities during rain or other inclement weather at your own risk. Any groups with participants under the age of 18 will have to follow IMG Academy weather policies. No refunds or credits will apply to your account due to weather.

#### **Supervision of Activities**

• You are responsible for all of the participants, guests and related personnel who enter the Academy Campus for your activities. Adequate supervision should be provided at all times.



Participant and his/her Parent/Guardian agree that this waiver, release from liability, and covenant not to sue specifically includes, but is not limited to, any claims for personal injury or illness (including death) as well as damage to, or the loss or theft of, any personal property. Participant and his/her Parent/Guardian further agree that this wavier, release from liability, and covenant not to sue has legal effect throughout Participant's enrollment in any IMG program, as well as each and every time IMG property or facilities are used by Participant, his/her guests, relatives, or family members, and agree that it shall be construed as if Participant and his/her Parent/Guardian acknowledged and attested to it throughout that time and upon each such use.

# AGREEMENT TO PARTICIPATE

ASSUMPTION OF RISKS: Physical activity, by its very nature, carries with it certain dangers and risks that cannot be eliminated regardless of the great care taken to prevent or minimize harm. IMG has facilities for various sport specific activities such as soccer, golf, tennis, baseball, football and basketball and related activities such as physical training, running, cycling and swimming. Some of these activities involve endurance or strenuous exertions of strength using various muscle groups, some involve quick movements involving speed and change of direction, some involve contact with equipment, fixed objects (e.g. goal posts), other participants (including participants that are older or younger and who may be larger or smaller in terms of weight and height) and various surfaces types, and others involve sustained physical activity that places stress on the cardiovascular and nervous systems. The specific risks vary from one activity to another, but in each activity the risks range from (1) minor injuries such as cuts, bruises, muscle strains and sprains, to (2) major injuries such as broken or fractured bones, concussions, or lost teeth, to (3) catastrophic injuries, such as heart attacks or fractured skull or those that cause disfigurement, loss of mental capacity, loss of sight, speech or hearing, paralysis, or death. I also understand that the Participant may be exposed, or expose others, to contagious and potentially harmful or deadly disease such as influenza, common cold, chicken pox, meningitis, or measles.
